

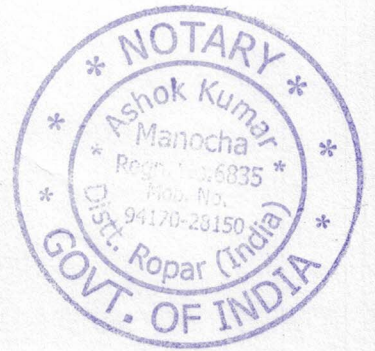

In future during inspection any complaint comes to light that wrong information was submitted at the time of taking objection Certificate from the Government, and the instructions issued by the Punjab Government from time to time are not complied with and the terms and conditions mentioned in the affidavit are not adhered to, then in that case this No Objection certificate can be withdrawn.

3. Teaching Punjabi in your school will be compulsory till 10th Standard and CBSE Delhi will ensure and make efforts to Conduct Punjabi examination is mandatory in such schools. It is also make clear that in case of not doing so, the No Objection Certificate will be withdrawn immediately.

4. School Management will strictly follow the Notification issued by Punjab Government under the RTE Act 2009 and rules of RTE Act 2009 made for the state of Punjab in the same spirit.

5. After receiving the Affiliation of CBSE New Delhi, the Management of the school will be committed to pay the salary and other allowances through Pay salary cheque to the Teaching Staff and Non Teaching Staff like Government employees. School Management shall deposit the requisite Reserve Fund of Teaching & Non Teaching Staff with the concerned District Education Officer in the event of School Extension/Up gradation shall deposit the requisite Reserve Fund, failing which the NO Objection Certificate shall be withdrawn immediately.

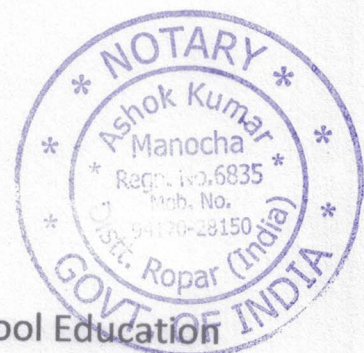
